Chairman's Comments

Welcome to our winter programme of walks. This newsletter is the first of a new pattern of publication. Traditionally we have included walks for the next four months with one month overlapping. When we were all dependent on paper lists it was useful to have that reminder, but now it is so easy to click on the website to check the next walk (many thanks to John and his daughter for their brilliant work in that regard) that is felt to be no longer necessary. Limiting the programme to the next three months makes it easier for the Rambles Secretary to get commitments from leaders.

The new pattern will be:-

End of November to cover December to February;

End of February for March to May;

End of May for June to August;

End of August for September to December.

The newsletter at the end of August will include the notice required for the AGM in September, as well as information about the committee and an invitation to nominate committee members for the following year.

We have been considering the future of the Canal & Countryside walks. The extra ten walks on top of the normal programme have stretched resources in terms of leaders, and although WLBC have printed the leaflets, distributing them is a burden. However C&C walks provide good publicity and do attract non-members some of whom go on to join WLFG. We have therefore decided to continue the C&C walks programme by limiting the normal afternoon walks in the summer months and focus on evening walks, while keeping the possibility of some longer walks. Any views about this will be very welcome.

As always, many thanks to committee members and to all leaders, without whose hard work we could not continue to provide what I hope you agree is a valuable service to the residents of West Lancashire and surrounding areas.
