Footpath news

A recent ramble in the Rufford area revealed two problems which have been reported to Lancashire CC and to Rufford Parish Council. Rufford Footpaths 9&10 form an important link from Brick Kiln Lane (and Mere Sands Wood) to the A59.

The paths run alongside a sluice with a wooden edging kept in place by metal tie wires into the bank. Erosion has caused the wires to become exposed, with a significant trip hazard. Be careful walking down these paths.

Rufford FP18 runs through Brick Kiln Farm. On approaching the farm from either end there are now substantial signs referring to a temporary closure, diversion and restriction for dogs. There is no indication of why there is a closure or how long this is intended to last. Our group walked the correct line with a dog without hindrance or seeing any reason for the restriction. This seems like an attempt to limit the use of a public right of way, and it is an accepted principle that a dog is a 'usual accompaniment' to a walker. Providing the dog is kept under control there should be no problem.

Other Matters

We are still keen to encourage members to become new leaders. The Committee are willing to mentor; do a recce with, or back mark for them until they feel confident that they can manage by themselves. If you wish to take up the offer, please get in touch with any Committee Member.

Also, we would like to expand our range of start points for walks – suggestions please (with appropriate parking spots).

Membership Matters



*The path runs for about 1 mile from Aughton Village Hall to St Michael’s Church. With cooperation from Lancashire County Council, Aughton Parish Council, the landowner and a contractor (Maiden Landscapes) the Merseyside & West Cheshire Group has done a substantial job of clearance, built a bridge over a brook and put in gates, fences and signs. **See a “before & after” pair of pictures on the home page of our Website.** In addition they have replaced the stile where FP10 meets the A59 with a kissing gate, provided by LCC. The project cost the group £1800, which was funded through a surplus on their Public Rambles over several years. We are most grateful to Merseyside & West Cheshire for their efforts and the use of their resources within West Lancashire.
